TERMS AND CONDITIONS

All sponsors and exhibitors must agree to the following terms and conditions for sponsoring and/or exhibiting at Plastics New Zealand's (PNZ) 2021 'Positively Plastics' Annual Conference at Rydges Hotel, Wellington which is coordinated and organised by Plastics New Zealand.

Bookings

Confirmation of exhibition space or sponsorship can only be made upon receipt of a completed 'Booking Form' and payment. To secure your sponsorship package or exhibition space, full payment must be made the month following the signing of the contract. All sponsorship opportunities are allocated on a first in, first served basis.

If you have chosen an option that has already sold, you will be contacted to arrange an alternate option acceptable to your organisation.

Cancellation

Cancellation of sponsorship or exhibition space must be received in writing. Cancellations received prior to 1st March 2023 will receive a refund of any monies received less a \$500.00 administration fee. For cancellations received after 1st March 2023 Plastics New Zealand reserves the right to retain all monies received unless a replacement sponsor can be found.

In the event that the PNZ 2021 'Positively Plastics' Annual Conference cannot be held due to acts of God, government, or other events beyond our control, sponsors and exhibitors will receive a proportionate refund of any monies available after fixed costs have been met. Plastics New Zealand will not be responsible for any further costs incurred by sponsors and exhibitors in connection with the event.

Liability Insurance

While every reasonable precaution is taken, the organisers expressly decline responsibility for any loss or damage which may befall the person or property of the exhibitor from any cause whatsoever.
