Bookings

Exhibition space or sponsorship is confirmed only upon receipt of a completed 'Booking Form' and payment. Full payment is required by the 20th of the month following invoicing to secure your sponsorship or exhibition space. All sponsorship opportunities are allocated on a first-in, first-served basis.

If payment is not received by the due date, your sponsorship opportunity may be reopened to other interested parties.

If your selected sponsorship option has already been allocated, we will contact you to discuss alternate options suitable for your organisation.

Cancellation

Cancellation of sponsorship or exhibition space must be received in writing. Cancellations received prior to 1st March 2025 will receive a refund of any monies received less a 5% administration fee on the total amount. For cancellations received after 1st March 2025 Plastics New Zealand reserves the right to retain all monies received unless a replacement sponsor can be found.

In the event that the Conference cannot be held due to acts of God, government, or other events beyond our control, sponsors and exhibitors will receive a proportionate refund of any monies available after fixed costs have been met. Plastics New Zealand will not be liable

for any further costs incurred by sponsors and exhibitors in connection with the event.

Liability Insurance

While every reasonable precaution will be taken, the organisers expressly decline responsibility for any loss or damage to person or property that may arise from any cause whatsoever.

Exhibitors/sponsors are advised to purchase adequate insurance cover, including Public Liability insurance.. Insurances are not included in the sponsor/exhibitor package cost. Exhibitors may be asked to provide a certificate of cover from their insurer.

You, your employees and your contractors must conform to the venue's health and safety requirements, and any other relevant operational policies and procedures.

Event

Registration

Admittance to the event or exhibition is strictly by name tag only. To participate in additional conference activities, a separate registration form may be required closer to the event. Sponsorship or exhibitor applications only entitle you to the benefits stated within your sponsorship package. Additional staff or guests will not be permitted access to the event or exhibition without a completed registration form. All registrations are transferable in full until 72 hours prior to the welcome event.

Artwork and Exhibiting

Sponsors and exhibitors are responsible for providing artwork, logos and text as required by the due dates. Plastics New Zealand is not responsible for publishing materials received after the deadline or in an incorrect format.

Logos and/or company names will be reproduced in the event colours, full colour, or monochrome, at our discretion. All logos should be at least 300 DPI at 100% in EPS (preferred for print) and JPEG (preferred for website) format. Recognition in print or on the web will only be provided if payment terms have been met.

You are granted a limited licence to exhibit. Assignment, sharing, sub-letting or licensing of all or part of tabletop display without prior approval is prohibited. Plastics New Zealand reserves the right to request the removal of any display items it deems unacceptable.

Business must be conducted solely within the boundaries of your tabletop display space, and materials may not be placed outside this area to avoid obstructing the aisles. You may not tout or place materials in other areas of the event such as plenary tables.

You are responsible for any reasonable costs incurred for painting, marking or damaging any fixtures or furnishings at the venue. You must familiarize yourself with the venue's terms and conditions prior to the exhibition date. Food, beverage or prohibited items (e.g. flammable or hazardous materials) are not permitted at the event unless by prior arrangement.

Privacy statement
